
US Residential Roofing Market Sector Review - August 2023



Residential Roofing Market Overview

- 367 advisors is glad to present US residential roofing market review for August 2023. The residential roofing market comprises of roofing material manufacturers, distributors and contractors providing solutions to homeowners
- Public roofing companies have performed strongly with the sector broadly outperforming the S&P 500 by 38%⁽¹⁾ over last 12 months. Robust equity performance of the sector was driven by strong share price growth of companies like Builders Firstsource, Owens Corning and Beacon roofing
- We believe that the market has strong tailwinds driven by growing trend of remodeling, increasing focus on sustainable housing, increasing demand for innovative specialty products and increasing construction activity of new homes
- M&A activity in the sector remained strong continuing the theme of roofing distributor consolidations
 - Holcim expanded its roofing platform by acquiring Duro for \$1.3Bn in Mar 23
 - Highly fragmented contractor market has seen increased M&A activity as small and mid-sized companies seek financial partners to scale

Residential Roofing - Key Market Drivers

Rise in Construction Activity

Eco-friendly and Recycled Roofing

- US construction industry's market dominance positively impacts the roofing sector through modern and modular structures
- Building permits for housing units increased by 5.2% y-o-y in May 23
- New construction in May 23 reached 1.63m up 5.7% y-o-y , driving the demand for roofing solutions
- Green roofs incorporate multiple layers on a traditional roof, including waterproofing and protective layer
- Increasing demand for recycled asphalt shingles (which incorporate 15% recycled materials) help reduce millions of tons of discarded asphalt ending up in landfills



- Energy-efficient roofing materials on the rise: Cool roofs, solar panels, and green roofs are gaining popularity for their ability to cut energy costs, enhance building thermal performance, and improve indoor air quality
- Solar roofing provides clean energy and lower electricity bills, driving homeowners to make the switch
- US solar roofing market set to reach \$965 Mn by 2025
 - New technologies increasing roof life, enhancing safety, improving air quality, and reducing noise & airconditioning costs are fueling the growth of the roofing market
 - Introduction of advanced technologies in aesthetics is set to strengthen the roofing market by elevating the visual appeal of roofs
 - Changing global climate leads to increase in roof damage from wind, hail and other weather incidents
 - Due to inclement weather, average roof's lifespan is now 10-12 years- driving remodeling or reroofing demand




80%+ Market Demand Driven by Re-roofing




Roofing Market Value Chain

M&A Update: Altas Creates Roofing Platform Tecta America

Altas Partners' platform approach using 'buyand-build' strategy

- Altas Partners acquired Tecta America in 2018 from ONCP a mid market private equity firm
- Tecta America, is a commercial roofing contractor in U.S. and is known for its broad array of services, including installation, replacement, repairs, and maintenance. With a nationwide presence through a network of over 60 locations. They have acquired more than 50 companies since inception
- Tecta America has built strong local relationships, contributing to its remarkable growth and success which Altas Partners recognized as a key source of strength
- Altas is using Tecta to build one of the largest roofing contractors in the US by completing 5 acquisitions - 3 in residential and 2 in commercial roofing space
- Roofing contracting is a highly fragmented market with multiple niche specialized services - ripe for consolidation and has attracted many PE firms targeting the platform approach

Acquisitions by Gauge Capital

- Gauge Capital launch Apple Roofing, a newly roofing contracting platform company after the acquisition Crest Exteriors LLC and Apple Roofing LLC
- Apple Roofing was formed to assist roofing companies who are seeking for capital solutions, ownership transitions and partnering with experienced executives to boost growth
- The aim is to build the largest regional roof repair and replacement company

Acquisitions Done by New State Capital Partners

- The acquisition of Patuxent marks New State's fourth and the third platform investment in New State Capital Partners Fund III
- This acquisition plans to pursue geographic expansion and explore a new sector of complementary building maintenance, repair, and renovation services
