# **Security Solutions (Fire & Life Safety) Market M&A Overview**

- Fire & Life Safety Solutions market continued to witness accelerated deal activity in 2023, with multiple strategic and PE backed acquisitions announced in line with the momentum of 2022
- Deal volume in first 3 quarters of FY23 was up ~35% compared to that of FY22
- **PE Platform deals:** BlackRock backed Summit companies announced acquisition of around 6 companies in various regions of USA in fire protection, alarm communications and safety solutions in 2023. Similarly, Altas Partners backed Pye-Barker Fire & Safety announced acquisition of California based Maximum Security and Comtron Systems in 2023
- **Strategic acquisitions** Endeavor Fire Protection acquired High Sierra Fire Protection Alarms in Aug, 2023
- United States fire safety market stood at ~US\$ 13 Bn in 2022 and is expected to grow at a CAGR of 9.3% to reach ~US\$ 18 Bn by 2025

**Key Trends Shaping Security Solutions Market M&A** 

M&A in Security Solutions and Fire Protection sees equally strong demand from strategic and financial buyers

Continued strong interest of PE funds through platform-based roll-up deals and add-on deals

Many M&A deals are focusing on combining cybersecurity with physical security solutions to offer comprehensive protection solutions

The increase in number of fire incidents in US and growing importance of regulatory standards provides continued resilience to Fire and Life Safety segment




